

# MEDICAL/POLICE REPORTS ON BABY SPECIAL CREATE CONTROVERSY

In the October and November 1989 issues of Miami Right to Life's newsletter, we reported an alleged case of infanticide at Baptist Hospital. Since then, three separate local investigations were opened and subsequently closed. The results of the investigations by Baptist Hospital, Metro-Dade Police Department, and the State Attorney's office all cleared the physician and the hospital of any wrongdoing.

What follows is a comparison of statements by some of the principles in 'ts case. Quotes come directly from the coroner's and police reports. The reader will see quotations from: the abortionist (DR.), an eyewitness nurse (NURSE), the Medical Examiner (ME), Baptist Hospital report (BAPT.), Florida statutes (FS), State Attorney's Office (SAO), and other eyewitnesses. It is important to note that standing at the foot of the bed during the delivery of this baby, was the abortionist, a nurse, and the baby's maternal grandmother. The baby had Down Syndrome, but had none of the typical physical characteristics of a Down's baby.

## QUESTION 1.

How far along was the pregnancy? DR: 23 1/2 weeks (2nd trimester) BAPT: 23 1/2 weeks (2nd trimester) ME: 24 - 26 weeks (3rd trimester almost 7 months)

**QUESTION 2.** 

How much did the baby weigh? ME: 900 grams (2 pounds) QUESTION 3.

How much did the baby measure?

Baptist Hospital is the medical facility that allowed a 3rd trimester abortion (Medical Examiner) of Baby Special. Officials at this health care facility stated that Baby Special was a stillbirth.

ME: 34.2 centimeters (almost 14 inches)

## **QUESTION 4.**

What happened to the child upon \_ delivery?

NURSE: I saw the baby's head emerge and within a second the whole body. The doctor immediately put it under linens at the foot of the bed.

DR: She (the patient) pushed and the fetus came out, and at that time I realized — well, she had told me that she did not want to see the fetus - so, what I did is that I covered the fetus with a sheet we have there. I put the sheets and blanket or whatever it was on top of the fetus.

## QUESTION 5.

Was the baby moving? **DR:** No.

NURSE: Quite a bit.

## **QUESTION 6.**

Was the baby breathing?

DR.: No.

ME: X-rays found pockets of air in the stomach, and the lungs were aerated (filled with air). The fetus breathed.

# **QUESTION 7.**

Was the child born alive? DR: No

BAPT: Stillbirth confirmed.

NURSE: I saw movement and moments after the birth the baby's grandmother told me she had seen it born alive.

ME: The fetus survived the abortion. It was a live birth.

## QUESTION 8.

When did the baby die?

DR: Before birth.

BAPT: D.O.A. (dead on arrival)

ME: 34 minutes elapsed until the fetus died.

## QUESTION 9.

Did the child have any obvious external abnormalities?

DR: The fetus had typical signs of mongolism.

NURSE: I went to uncover (the baby) and he (the abortionist) told me there was no need to, that the baby had gross abnormalities. But when I finally saw the child I realized there were no apparent abnormalities at all.

ME: The scalp is covered by blond hair. The head is normal, the nose is normal, the ears are normal, the face is normal, the lips are normal, the chest is symmetric, the neck is normal, the upper extremities are normally formed, the lower extremities are normally formed.

GRANDMA: The baby was beautiful.

## QUESTION 10.

What was the cause of death?

SAO: The fetus died of natural causes.

ME: Cause of death was prematurity due to therapeutic induction of labor.

## **QUESTION 11.**

Was there a pre-delivery discussion amongst the medical team of what procedure was to be taken if a live birth were to occur?

DR: No.

NURSE: We discussed it. I told him (Dr.) that if it comes out alive it has to go to Special Care and he said he was aware.

DR: When a fetus is aborted...you normally don't do anything. You let the fetus expire. The usual thing is just to take your time...

## QUESTION 12.

What is the procedure to be taken if a baby survives an abortion?

NURSE: I will clean the baby off and if the baby appears to be alive, I take it to the nearby Special Care Nursery.

FS: Florida Law 390.001 sec. 5. If a termination of pregnancy is performed during viability, no person who performs or induces the termination of pregnancy shall fail to use that degree of professional skill, care, and diligence to preserve the life and health of the fetus...

DR: When a fetus is aborted, sometimes there is some activity in the fetus and you normally don't do anything. You let the fetus expire. The usual thing is just to take your time, don't immediately do anything. I knew there was some fetal activity, and I knew that the mother of the patient (baby's grandmother) wanted to see the fetus, and I didn't want her to see any kingof activity, so I decided to wait to see if there was any more activity.

# **QUESTION 13.**

Was the child actively smothered by the abortionist?

NURSE: No.

ME: No.

DR: No.

As noted at the beginning, information is compiled and organized so it is easier to identify a consensus or a contradiction of facts. The most notable contradiction is the condition of the baby at birth. The abortionist clearly states that the child was delivered dead. He wrote that on his report, and Baptist hospital confirmed a stillbirth. But troubling to pro-lifer groups is the nurse's testimony that there was quite a bit of movement from the child, the grandmother's comments to the nurse that she too had seen the baby born alive, and the medical examiner's report that clearly shows the child survived the abortion.

When the nurse attempted to uncovy the still moving child, the doctor told her not to, "because it had gross abnormalities." But as the nurse later realized that was not true.

Autopsy X-rays and a close examination of the child's lungs showed that the baby breathed for some time. The doctor claims he saw no breathing.

The abortionist also said that there was no movement, but he later admitted that 30 minutes after delivery he was waiting to see if there was "any more fetal activity." The abortionist then explained that those movements were simply muscle contractions.

The police report says that there is no reliable testimony that indicates the abortionist actively smothered the baby. But the question being raised by MRTL is why was no medical assistance given as required by law? The law does require help for any viable baby surviving an abortion. But the abortionist in this case states that his usual procedure is to "not do anything and let the fetus expire, don't do anything immediately." This is in contradiction a Florida law.

The pro-life community feels that the state attorney's office cleared an abortionist of negligence without possibly taking into serious consideration the testimony of eyewitnesses and medical facts. When children born at this age are given the proper medical attention, the survival rate is quite high. A live birth is considered a complication during an abortion, and the legal ramifications of a "botched abortion" could have been quite costly to the doctor and the hospital.

There are an estimated 400 late-term abortions performed daily in the United States. Some of these babies die in the manner this little boy did. Miami Right to Life asks each person reading this to examine the facts stated above, and to then ask him/herself if they agree with the police, the State Attorney's office and Baptist Hospital's findings. Does the reader agree that there was no wrong doing or negligence on behalf of this doctor? Does the reader agree that this man should have been exceptionally cleared?

# VICTIMS OF ABORTION-WE CAN HELP

"Do not call to mind the former things, or ponder things of the past. Behold, I will do something new, now it will spring forth; will you not be aware of it? I will even make a roadway in the wilderness, rivers in the desert." Isaiah 43:18,19

After the Supreme Court made its inglorious decision in 1973 on the rights of women to obtain an abortion, few people realized the awful lingering consequences and aftereffects of this supposed "safe" procedure. However, 17 years later, an interesting pattern of maladies has developed giving rise to the recent research centered around what is now termed Post Abortion Syndrome (PAS). What is most interesting is that those developing these classified disorders, the VICTIMS of abortion, are not just the women who had the abortion. Others, like the men who were involved with the pregnancy, the grandparents and children within the family, have fallen prey to this heinous slaughter of innocent children.

PAS is taking hundreds of thousands baptive every year. Researchers are now beginning to understand why these victims all seem to have the same types of long-term disturbances.

PAS has been described as the inability to: (1) process the fear, anger, sadness and guilt surrounding an abortion experience, (2) grieve the loss of the baby, and (3) come to peace with God, themselves and others involved in the abortion decision.

Although, to date, most PAS counselling has been directed toward the woman who had the abortion, there is currently a door opening to reach all those who have been victimized. That door is American Victims of Abortion or AVA.

"When I was a young girl, I used to try to fix broken tea cups for my mother. I would put the shattered pieces together with a bit of glue and then gently hold them until they started to bond. I would be so pleased when the pieces became one again and the little cracks were hardly noticeable."

Post aborted women and men are iuch like these cups. There is one piece of their lives which is cracked, blemished, and ugly. They are dangling like chips and pieces waiting for someone to come along who knows what is wrong and how to fix them, someone to glue them back together, hold them gently and place them back on the shelf of life.

AVA has establish a three (3) point direction to accomplish this task:

1. Counsel women and men in the local community who desire counselling. Then, direct them, after healing into three programs:

A. Public speaking and lobbying locally and in Tallahassee.

B. Assisting AVA and MRTL with various projects to continue their healing process.

C. Train healed women and men to counsel other post aborted victims.

2. Build a strong speaker's bureau from those who have been counseled.

Speakers are needed to give presentations on the aftereffects of abortion to: media, churches, physicians, high school and college students, organizations, and legislators (locally and in Tallahassee).

3. Build a prison ministry.



Many women and men in prisons are suffering from the aftereffects of abortion (especially substance abuse).

These victims can be restored to usefulness within their community and then can be instructed to build a ministry to reach other inmates.

Post aborted women and men are the broken cups. American Victims of Abortion, with the Lord leading the way, is the glue and the hands to hold them gently until they are healed.

# WARNING!!!

When "birth control pills" were firs, introduced, they were professionally called oral contraceptive tablets. That was a good description, because they prevented ovulation (release of a female egg), and therefore conception was virtually impossible.

As these products were used over as period of time, it became clear that they caused serious side effects, particularly the formation of dangerous blood clots (thromboembolic disease). In order to reduce the occurrence of these side effects, the tablets were reformulated to contain less estrogen.

Because of the lower dose of estrogen there is a very important change in effect: ovulation sometimes takes place. The released female egg is sometimes fertilized; in other words, there is conception. If conception occurs, the action of tablets cannot accurately be described as contraceptive.

These new birth control pills are still considered to be effective because the living embryo will be eliminated by another effect. The lining of the woman uterus is changed so that the embryo can not attach and receive nourishment. At an age of 1 or 2 weeks, the embryo will be removed from the body in a menstrual type bleeding.

Since April 1988, all of the birth control pills marketed in the United States are of a new type. Those who provide them generally continue to describe their mechanism of action as contraceptive. Actually, to directly prevent the survival of a fertilized egg is to induce abortion.
