STIPULATION FOR  
CONSENT ORDER

WHEREAS, on April 14, 1987, the Minnesota Board of Medical Examiners ("Board") issued an order revoking the license of Hideo D. Mori, MD ("Respondent") to practice medicine in Minnesota and ordering Respondent to pay a civil penalty of \$10,000; and

WHEREAS, on April 30, 1987, Respondent petitioned the Board to reconsider its decision, particularly with respect to the civil penalty; and

WHEREAS, Respondent has a right to seek judicial review of the Board's order; and

WHEREAS, Respondent is willing to waive his legal right to challenge the Board's revocation of his license to practice medicine in return for Board action rescinding the civil monetary penalty;


NOW, THEREFORE, IT IS HEREBY STIPULATED AND AGREED as follows:

1. Respondent expressly waives any legal right or remedy available to him to appeal to the Minnesota Court of Appeals or otherwise challenge, in any state or federal court, the Board's April 14, 1987 order revoking his license to practice medicine;
2. Respondent shall not practice medicine in Minnesota and he waives any right to ever apply for a license to practice medicine in Minnesota;
3. The Board shall issue the attached consent order rescinding that portion of its April 14, 1987 order imposing a civil penalty on Respondent;


4. Any appropriate State or Federal court shall, upon application of either party, enter an order enforcing any of the terms of this Stipulation or the Consent Order;

5. Respondent hereby acknowledges that he has read and understands this Stipulation, has been advised by counsel, and has voluntarily entered into the Stipulation without threat or promise by the Board or any of its members, employees, or agents. This Stipulation contains the entire agreement between the parties, there being no other agreement of any kind, verbal or otherwise, which varies the terms of this Stipulation.

CONSENT ORDER


Upon the attached Stipulation for Consent Order,
