This correspondence is in response to your May 27, 2016 letter, received on May 31, 2016, requesting "...public records that relate to reports of alleged sex-traffickers at four Virginia Planned Parenthood clinics in Roanoke, VA, Falls Church, VA, Richmond, VA and Charlottesville, VA on January 11 and 12, 2011." As you may be aware, requests for records of the Commonwealth, its agencies and political subdivisions are governed by the *Virginia Freedom of Information Act* (FOIA), §§ 2.2-3700 *et. seq.*

Pursuant to Virginia Code § 2.2-3704(B)(3), the requested records could not be found or do not exist.

Additionally, records relating to criminal intelligence or any terrorism investigation is excluded from the provisions of FOIA pursuant to § 52.48. A request for records of this type would be declined on the cited grounds.

You may also direct your request to the Federal Bureau of Investigation and to local law enforcement agencies for responsive documents.

I write to call to your attention to recent incidents at several health centers operated by affiliates of the Planned Parenthood Federation of America. These incidents suggest that an individual or multiple individuals are engaged in activities that violate several federal criminal statutes relating to sex trafficking involving minors. We believe these incidents should be investigated by the Federal Bureau of Investigation and, if appropriate following that investigation, prosecuted by the Department of Justice.

These incidents occurred at Planned Parenthood health centers in Arizona, Indiana, New Jersey, Virginia, and Washington, D.C. In each, a man has sought information about services relating to testing and treatment for sexually transmitted diseases, abortion, and services for minors. In conversations with our staff, he has disclosed that he is involved in the sex trade, that some of the women involved are minors, and that some are in the United States illegally.

Members of our staff have made it clear to this man that Planned Parenthood's first priority is the welfare of our patients, including minors seeking medical testing and treatment, and that we are obligated to comply and will comply with applicable state laws relating to reporting of suspected instances of conduct that endangers the welfare of minors.

These multi-state visits from men claiming to be engaged in sex trafficking of minors may be a hoax. In the past, Planned Parenthood affiliates have been approached by a small, organized group of people, opposed to our mission, who have misrepresented their circumstances to gain access to our health centers. Once inside, these people have recorded "undercover" videos of their conversations with our clinic staff and then selectively and maliciously edited the videos in an attempt to cast Planned Parenthood in a negative light. This may be happening once again. If so, this kind of activity should be firmly condemned.

However, if the representations made by this man are true, we believe that they indicate possible violations of at least the following federal criminal statutes: 18 USC 1591 (sex trafficking of children in interstate commerce), 18 USC 2421 (transporting an individual in interstate commerce for purposes of prostitution), 18 USC 2422 (inducing an individual to travel in interstate commerce for purposes of prostitution), and 18 USC 2423 (transporting a minor in interstate commerce for purposes of prostitution).

We are writing you about a matter of the utmost gravity and urgency. Videotapes released by Live Action throughout the past week have showed Planned Parenthood staff members in New Jersey, Virginia, D.C., and New York willing to aid and abet undercover actors posing as self-identified sex traffickers of girls as young as 14. Some Planned Parenthood staff even advised how underage prostitutes could continue their prostitution while they recovered after their abortions.

On January 18, 2011 [redacted] of Planned Parenthood Federation of America, Inc., wrote you to report "incidents" that occurred at several Planned Parenthood facilities. [redacted] wrote that a man told Planned Parenthood staff "that he is involved in the sex trade, that some of the women involved are minors, and that some are in the United States illegally." [redacted] stated that the Planned Parenthood facilities visited were "in Arizona, Indiana, New Jersey, Virginia, and Washington, D.C." (emph. added).

[redacted] letter raises an alarming concern. Live Action **did not** visit any Planned Parenthood facility in Indiana. In our investigation of Planned Parenthood's willingness to aid and abet human trafficking, Live Action only visited New Jersey, Virginia, New York, Washington, DC and Arizona. Thus the startling conclusion can be drawn from [redacted] letter that one or more of Planned Parenthood's Indiana facilities did either provide, or offer to provide, services to an actual sex trafficker.

Since [redacted] letter suggests that Planned Parenthood may have hosted actual sex traffickers at one or more of its Indiana facilities, and given that we have video and audio proof of its institutionalized willingness to aid and abet such sex traffickers, Live Action requests that your office begin an immediate and thorough investigation in Planned Parenthood of Indiana – and elsewhere.

Our past four years of investigative research shows that the Planned Parenthood Federation of America and its affiliates institutionally and systematically cover up the sexual abuse of young girls.

Furthermore, our latest research reveals that Planned Parenthood and its affiliates are willing to aid and abet the sexual abusers and traffickers of children.

The unedited, full footage videos we already have released (www.liveaction.org), coupled with [redacted] own letter to you, affords ample evidence to establish the urgent need for immediate investigation into Planned Parenthood of Indiana and affiliates of Planned Parenthood across our nation.

We hope that together, we can work to ensure that the sexual exploiters of children will no longer be tolerated in this nation and abetted by Planned Parenthood.

On July 28, 2016 the Indiana Department of Child Services (DCS) received your letter dated June 25, 2016. In your letter, you request records pertaining to Planned Parenthood. Specifically, you are requesting reports made by Planned Parenthood or its employees relating to sex-traffickers, pimps, and/or prostitutes at any Planned Parenthood Centers in Indiana during January and February of 2011.

In our letters to you dated June 6, 2016 and June 23, 2016, we advised that any report received in our agency relating to the subject described in your letters would have been made to our hotline. These reports are classified as confidential under Indiana Code (IC) § 31-33-18-1 and are only available for release to those individuals or entities as specified in IC § 31-33-18-2. A copy of IC § 31-33-18 was included for your reference with our letter dated June 6, 2016. We cannot determine that you are a person authorized to receive reports made to DCS under IC § 31-33-18-2.

In our letter dated June 6, 2016, in an attempt to explain we could not search for your proposed parameters, we advised that “[a] search for any written report could be done based on the name of the reporter ... or the name of the alleged victim(s)”. We also advised we were denying your request for those reports under IC § 31-33-18-2.

DCS Policy Chapter 2, Section 6 states: “The Indiana Department of Child Services (DCS) will hold confidential all information gained during reports of Child Abuse and/or Neglect (CA/N), CA/N assessments, and the provision of ongoing case management services. The identity of the reporting source, children, and others protected by law must be held


