

Some takeaways from Planned Parenthood's 2015-16 annual report

Planned Parenthood delayed release of its [2015-16 annual report](#) for months. What do the numbers reveal?

- **PP is LOSING clients and REDUCING what few health services it offers to women, yet it has managed to INCREASE its abortions – and its revenues (\$77.5 million in excess revenues in 2015).**
 - The alarming new numbers continue to make it clear that PP's focus is abortion at the expense of women's health care.
- **Abortions are increasing at PP even when the Guttmacher Institute reports they're declining nationally.**
 - PP committed 328,348 abortions in 2015 vs. 323,999 in 2014 (over 4000 more in 2015)
 - Nearly 900 abortions every day
 - PP did 2,889 adoption referrals in 2015. It committed nearly 114 abortions for every one baby it referred out for adoption.
- **PP claims prenatal care and breast exams are core services that justify taxpayer funding. Yet its almost nonexistent prenatal care was cut nearly in half, and breast exams are down 12 percent in a single year.**
 - Prenatal services – 17,419 (2014) decreased 46% to 9,419 (2015). This tiny number was out of the 9.5 million total “services” PP says it did in 2015.
 - Breast exams - 363,803 (2014) decreased 12% to 321,700 (2015). Note that these are NOT mammograms. Despite past claims by PP and its supporters, no PP does mammograms.
 - In 2015, Planned Parenthood committed more abortions (328,348) than it did breast exams (321,700). Its own numbers prove exactly where its priorities lie.
- **PP says that redirecting taxpayer funding away from it to community health centers would harm its clients, but its clients continue to leave PP on their own.**
 - PP lost another 100,000 clients last year, on top of the half million clients it already lost since 2011.
 - 3 million clients in 2011 are down to 2.4 million in 2015.
- **Government funding went up slightly even though PP served 100,000 fewer clients and cut many services.**
 - \$553.7 million (2014) increased to \$554.6 million (2015)
 - Every day we delay defunding PP, it receives another \$1.5 million from taxpayers to keep its doors open.

Other numbers from the annual report:

- Excess revenue over expenses (“profit”) - \$58.8 million (2014) increased 32% to \$77.5 million (2015)
- Private funding - \$353.5 million (2014) increased 26% to \$445.8 million (2015)
- Adoption referrals – 2,024 (2014) increased 43% to 2,889 (2015) – but it’s still negligible. This tiny number was out of 9.5 million total “services” PP says it did in 2015.
- Contraceptive services - 2,945,059 (2014) decreased 4.6% to 2,808,815 (2015)
- PAP tests - 271,539 (2014) increased 8% to 293,799 (2015)
- STI testing and treatment - 4,218,149 (2014) stayed fairly consistent at 4,266,689 (2015)

Looking at the 10-year trends, 2005-2015

WHAT’S DOWN? – The services PP claims it is so critical in providing

- Prenatal services – **NEGLIGIBLE TO BEGIN WITH, AND DOWN 29% 2005-2015.** 13,261 out of 10.1 million total “services” (2005) vs. 9,419 out of 9.5 million total “services” (2015)
- Breast exams – **DOWN 62% 2005-2015.** 842,399 (2005) vs. 321,700 (2015)
- PAP tests – **DOWN 74% 2005-2015.** 1,116,681 (2005) vs. 293,799 (2015)

WHAT’S UP? – The things it downplays

- Abortions – **UP 24% 2005-2015.** 264,943 (2005) vs. 328,348 (2015)
- Government funding – **UP 82% 2005-2015.** \$305.3 million (2005) vs. \$554.6 million (2015)

Also of note:

- Contraception - **DOWN 25% 2005-2015.** 3,744,498 (2005) vs. 2,808,815 (2015)
- STI testing and treatment – **UP 47% 2005-2015.** 2,899,066 (2005) vs. 4,266,689 (2015)
